Immigration procedure for non-EU national (guest) employees

- ◆ Advice on residence permit application (income requirement, required documents and time frame)
- ◆ Coordinate collection and signing of required documents with HR and employee
- ◆ Submission of application to the Dutch Immigration Services (IND)
- ◆ Guidance during immigrations process
- ◆ Pre-registration BSN
- ◆ Welcome meeting with employee shortly before or after arrival (online or at Welcome Center)
- ◆ Coordinate appointments with IND (biometrics and/or collect residence documents) and municipality (registration BRP and receive BSN)
- ◆ Information about healthcare insurance, opening a bank account and mandatory Tuberculosis test (i/a)

- ◆ Information on working and living in the Netherlands
- ◆ Pre-registration BSN
- ◆ Coordinate registration appointment with municipality
- ◆ Information on health insurance and open bank account
